## **WRCTC Donates** \$10,000 to Rancher **Relief Fund**

The WRCTC Board of Directors approved a \$10,000 donation to the South Dakota Rancher Relief Fund (RRF) to assist livestock producers who experienced devastating losses due to the winter

storm Atlas that struck our area in early October 2013. The RRF was established on October 8, 2013, by the SD Stockgrowers Association, SD Cattlemen's Association and SD Sheepgrowers Association; and the fund grew quickly and substantially. With over 5,000 individuals, organizations and businesses from across the state and nation donating money, the fund grew to over \$4 million. "We know that these funds will not make anyone whole again, however, we are hopeful that the money will help people get to the next step," stated Silvia Christen, Executive Director for SD Stockgrowers.

Within our service territory, WRCTC directors and employees saw our livestock producers struggling to piece their lives back together. Storm Atlas not only plagued our service territory with electrical 374-3167 and communications outages, but it created hardships for our neighbors, families and friends. Over 240 applicants from our surrounding counties applied for aid from the

## South Dakota's Broadband Initiative wants to hear from Ag Producers

The state's Broadband Initiative, led by the Bureau of Information and Telecommunications (BIT), partnered with the United States Department of Agriculture (USDA) Field Office in South Dakota to survey agriculture producers across the state for the second time to assess the availability of high-speed broadband Internet services in rural areas.

Approximately 6,500 surveys were mailed this month to South Dakota agriculture producers encouraging participation in this Internet Usage Survey. The survey requests information from 257-2391 agriculture producers asking if they subscribe to an Internet service, how they utilize the service, how availability, speed, and affordability impact their utilization. The results of the survey will guide state policy decisions encouraging providers to expand areas of service or enhance the quality of high speed broadband internet services in South Dakota.

The ultimate goal of the Broadband Initiative is to increase the usage of high-speed broadband Internet to all of South Dakota with an emphasis on rural areas. Assessment of the availability and utilization of high speed broadband Internet services within agriculture, the primary economic driver across the state, is extremely important to this project. If producers did not receive the survey or misplaced

it, you can request a copy be mailed to you by calling 1.800.338.2557 or you can simply take the survey online by visiting <a href="http://broadband.sd.gov/AgricultureSurvey.aspx">http://broadband.sd.gov/AgricultureSurvey.aspx</a>. Survey results will be available online in 374-5880 the spring.

"Based on comments received from the 2012 survey, we learned many respondents were just beginning to subscribe to Internet services. This is the primary reason we are again asking for participation in the survey; we want to measure changes in the availability and utilization of high speed Internet services and assess the impact these services have on our agriculture community and rural areas across the state. High-speed broadband Internet services can expand educational opportunities, improve public safety, enhance health care delivery and bring economic growth to the region. Utilization also improves producers' ability to market livestock, forage and grain providing a competitive advantage and improving the state's rural economy," stated David Zolnowsky, BIT Commissioner.

### Monitor your Livestock the Comfy Way


Make your life easier and less stressful during calving season.

### \$2,500 FRS Scholarship

The Foundation for Rural Service (FRS), a branch of the National Telephone Cooperative Association, is offering 30 scholarships nationwide. These scholarships are \$2,000 each, and all high school seniors whose parents are a member of West River Cooperative Telephone 374-5304 Company (WRCTC) are eligible to apply.

Should a student from our service area be selected to receive one of the 30 scholarships, WRCTC will make a \$500 matching contribution to the scholarship, bringing the total scholarship award to \$2,500!
